ORDINANCE #10-26

AN ORDINANCE OF THE TOWNSHIP OF RARITAN, COUNTY OF HUNTERDON, STATE OF NEW JERSEY, TO AMEND AN ORDINANCE ENTITLED REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF RARITAN, AND MORE SPECIFICALLY TO AMEND TITLE 16, CHAPTER 16.14 APPLICATION AND FILING PROCEDURES AND MORE SPECIFICALLY SECTION 16.14.010 GENERAL PROCEDURES FOR SUBDIVISION AND SITE PLAN APPROVAL

BE IT ORDAINED by the Mayor and Township Committee of the Township of Raritan as follows:

Section I

Section 16.14.010 G. 2 shall be amended and supplemented as follows:

- G. Exceptions from Site Plan Review
- 2. Change of use from one permitted use to another permitted use on premises or in any existing structure which complies with all zoning requirements for the new use, including but not limited to use, bulk, area, parking, hard surface requirements, coverage and floor area requirements are exempt from site plan review requirements of this title, unless otherwise required by the floodplain ordinance.

Section II

If the provision of any article, subsection, paragraph, subdivision or clause of this Chapter shall be judged invalid by any Court of competent jurisdiction, such Order or Judgment shall not effect or invalidate the remainder of any such article, section, subsection, paragraph or clause, and to this end, the provisions of this Ordinance are hereby declared to be severable.

Section III

All other provisions of the said ordinance shall remain in full force and effect.

Section IV

The Township Clerk is directed to give notice at least ten days prior to a hearing on the adoption of this ordinance to the Hunterdon County Planning Board and to all other persons entitled thereto pursuant to N.J.S.A. 40:55D-15, and N.J.S.A. 40:55D-63(if required).

Section V

After introduction, the Township Clerk is hereby directed to submit a copy of the within Ordinance to the Planning Board of the Township of Raritan for its review in accordance with N.J.S.A. 40:55D-26 and N.J.S.A. 40:55D-64. The Planning Board is directed to make and transmit to the Township Committee, within 35 days after referral, a report including identification of any provisions in the proposed ordinance which are inconsistent with the master plan and recommendations concerning any inconsistencies and any other matter as the Board deems appropriate.

Section VI

This ordinance shall take effect immediately upon (1) adoption; (2) publication in accordance with the laws of the State of New Jersey; and (3) filing with the Hunterdon County Planning Board.
